A PROCLAMATION.

GEORGE, P. R.

WHEREAS a Definitive Treaty of Peace and
 Friendship between His Majesty and His
 Most Christian Majesty hath been concluded at
 Paris on the thirtieth day of May last; in confor-
 mity thereunto, We have thought fit, in the name
 and on the behalf of His Majesty, hereby to com-
 mand, that the same be published throughout all

peace do call for public and solemn acknowledg-
 ments, have thought fit, in the name and on the
 behalf of His Majesty, and by and with the ad-
 vice of His Majesty's Privy Council, to issue this
 Proclamation, hereby appointing and commanding,
 that a General Thanksgiving to Almighty God
 for these His mercies, be observed throughout
 those parts of the United Kingdom called England
 and Ireland, on Thursday the seventh day of July
 next; and for the better and more devout solemn-
 ization of the same, We have given directions to
 the Most Reverend the Archbishops, and the Right
 Reverend the Bishops of England, to compose a
 Form of Prayer, suitable to this occasion, to be
 used in all churches and chapels, and other places
